**Parent/Student Agreement for Mobile Learning Initiative**  
**Grades 6 – 9 Only**

I (Parent/Guardian) \_\_\_\_\_ give permission for my student \_\_\_\_\_ to use his/her assigned Mobile Device in school and for my child to take the assigned device off of the Southwest ISD campus. My child and I understand the following:

1. Students must bring the **fully charged** device (tablet), the carrying case, the charger, the keyboard, and the tablet and keyboard cover to school on a daily basis, unless otherwise directed by school staff.
2. Students should have no expectation of privacy in regards to use of the device. School administration and teachers have the right to access all data and information on the device.
3. The Mobile Device is the property of Southwest ISD. Parents and students agree that it will only be used in accordance with the SWISD Acceptable Use Policy (AUP) and the guidelines enclosed in this packet.
4. Students involved in after school activities must store their mobile device in designated areas.
5. Parents and students are responsible for making sure the device is kept in a safe place during home use.
6. Parents and students agree that all “apps” and content to be installed on the device must be pre-approved by Southwest ISD school administration.
7. Students must keep the device in the protective case at all times when not in use.
8. Students must return the device and accessories no later than later than the last day of school unless earlier terminated by the District or upon withdrawal from the District.
9. All assigned mobile devices may be seized and inspected at any time without notice.
- 10. Parents/Guardians will be assessed a non-refundable Mobile Device Usage fee of \$40.00 (Select from the three payment options below)**
11. Parents/Guardians are responsible for the full cost of lost or stolen devices, and any cost needed for repairs caused by neglect or misuse of the device. The total cost of the device and its accessories is \$682.00. The price details are as follows:
  - a. Tablet Device                      \$528.00
  - b. Keyboard & Case                      \$122.00
  - c. Tablet Shield Case                      \$15.00
  - d. Carrying Bag                      \$17.00
12. If the user does not fully comply with all terms of this Agreement and the SWISD Student Handbook Acceptable Use Policies, the District shall be entitled to declare the use in default and terminate users’ rights of possession effective immediately.

**Please select from the following payment plans by circling A, B, or C:**

- A. One time payment of \$40.00, due upon submitting this form
  
- B. Two payments of \$20.00 each. The first payment will be due upon submitting this form. The second payment will be due no later than one month (30 days) after the first payment. If the deadline is on a day that school is not in session, the payment will be due immediately on the day the student returns to school.
  
- C. Four payments of \$10.00 each. The first payment will be due upon submitting this form. Subsequent payments of \$10.00 will be due every 30 days after that. Full payment should be completed no later than 90 days after the date of the first payment. If the deadline is on a day that school is not in session, the payment will be due immediately on the day the student returns to school.

By signing below, I agree to pay the \$40.00 usage fee and to the expectations and procedures as detailed in the SWISD Acceptable Use Policies found in the student handbook and on the guidelines and regulations on this document.
